Council Inquiries:

Administration responded to an inquiry about snow removal for the Clive Athletic and Agricultural Society (CAAS). CAAS and the Village could enter into a Snow Removal Hold Harmless Agreement however Clive may not be able to meet their needs in a timely manner. The Village's snow removal policy indicates snow can be cleared on non-profit properties on a third priority basis; after all village streets are completed.

Council also inquired about the availability of reliable, hard-wired internet so that CAAS could live stream from the arena. Administration responded that Clive is not eligible for broadband grant funding because according to the Canadian Radio-television and Telecommunications Commission (CRTC) records, Clive is considered to already have adequate internet coverage meeting minimum speed requirements through existing providers. A cnWave wireless mesh system may be a more affordable alternative to fibre internet.
